## RAPS and EDPS Submissions

### RAPS Submissions

Our Risk Adjustment Processing System (RAPS) solution submits acceptable, risk-adjusting diagnosis codes to CMS. All of your claims and supplemental records are deduped and filtered in accordance with CMS submission rules. The solution includes online tools including an error/edit tool allowing you to make corrections within the system and automatically recycle. This provides configurable error queues and workflows to help you manage your submissions. These tools also include an end-to-end reconciliation of claims and supplemental records. Tessellate also offers financial forecasting based on RAPS return data allowing you to easily track CMS revenue and accrue for CMS true-up payments.

### EDPS Submissions

Tessellate's proprietary, CMS-certified Encounter Data Processing System (EDPS) logic provides you with an end-to-end solution within our platform for formatting, validating, submitting, and reconciling encounter data. The solution includes submission of professional, institutional, DME, and supplemental data files. Errors returned from CMS are displayed in our online portal, along with tools that enable you to correct errors within the system and automatically recycle.
